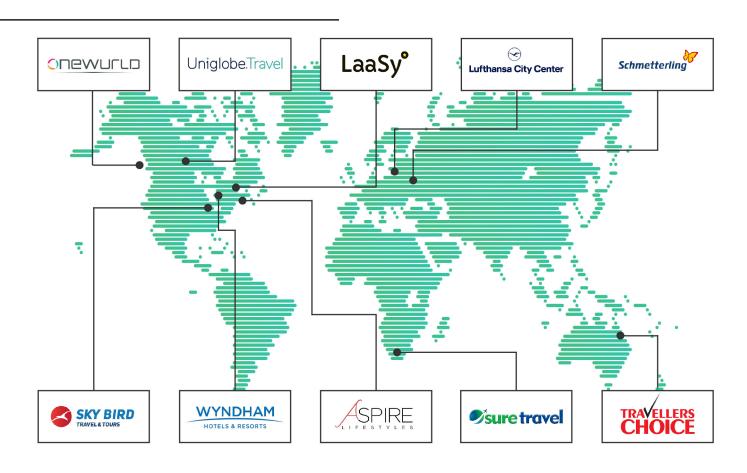

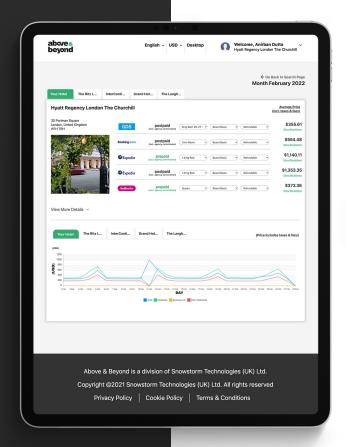

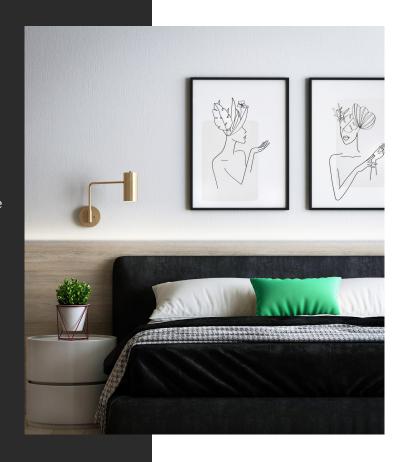

TERMS

& CONDITIONS

All terms and conditions quoted are for the period January 1, 2026, to December 31, 2026.

- All rates to be parity or better than other Travel Agent Companies and Travel Agent Consortia Hotel Programmes.
- All rates must be made available in the GDS/online by December 2025.
- GDS rate to be commissionable, with a minimum of 8% unless otherwise agreed.
- The Agreement between Above & Beyond and the Hotel may be cancelled at any time with 90 days written notification either by Above & Beyond or the Hotel. There will be no refund of fees in this case.
- All bank charges are to be paid by the payee. Failure to do so will result in Above & Beyond recovering all charges from the Hotel / Supplier.
- The Hotel agrees to honour all rates for existing and new clients throughout the period quoted.

- Room Guarantee Policy All guests confirmed on our exclusive rate code must not be refused a room. Should this be unavoidable then the Hotel agrees to source a comparable alternative, provide free of charge transportation to an alternative property, and pay for one long distance telephone call.
- Rate Audit Programme Once you have loaded the rates on or before December 31, 2025, an automatic rate check will take place in Q1– checking that your rate is visible within the GDS as well as ensuring that the value-added benefits are clearly identified at the time of booking. Please note that this is not applicable to chainwide agreements.
- Provision of your data to participate with Above & Beyond is deemed as authorisation
 and agreement to our terms and conditions, including fees. Payment terms are 30
 days from date of invoice. Our prices quoted exclude UK VAT. UK VAT will be charged,
 where relevant, in accordance with local and EU regulations.
